What is this product?

The Fund is an alternative investment fund and a sub-fund of Carnegie Wealth Management Fund SICAV ("CWMFS"), an investment company with variable share capital (SICAV) organized as an umbrella fund governed by Luxembourg law.

The Fund is open-ended but may, at any time, be dissolved by decision of the shareholder's meeting. For more information about this, see the Prospectus of the Fund.


Objectives

The Fund, with regards to its level of risk, aims to achieve a positive long-term return. To achieve this, the Fund invests primarily in exchange traded funds, UCITS and alternative investment funds that in return invest in fixed income. The fixed income securities can be issued by corporate institutions, governments or other organisations and largely consist of placings with a lower credit rating. The investments are made based on an analysis of the managers strategy, experience and competence, investment process and historical results. The Fund can also invest in derivative instruments, both long and short, both to protect (hedge) the assets of the Fund and to take active market risk and may as well enter into securities lending transactions to improve performance and generate income.

The Share Class does not pay dividends, all income and capital


What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



Shareholders may redeem its shares any day on which banks are open for business in Luxembourg, other than 24 December.

Intended Retail Investor

The Fund may be suitable for investors planning to keep the investment for 3 years and who understand that the money invested in the Fund can both increase and decrease in value and that they may not get back the full amount invested. Investors should have a basic knowledge and/or experience of UCITS funds and financial markets.

The performance of the Fund depends on if the Fund's investments increase or decrease in value during the holding period.

Performance Scenarios

What happens if Carne Global Fund Managers (Luxembourg) S.A is unable to pay out?

What are the costs?

Costs over time

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The Fund has no minimum holding period but as it invests funds that invests in fixed income it is suitable for investors with a medium-term investment horizon. Investors should be prepared to hold the fund shares at least until the end of the recommended holding period. The Fund is normally open for subscriptions and redemptions any day on which banks are open for business in Luxembourg, other than 24 December.
